5.2. Special hazards arising from the substance or mixture.

HAZARDS CAUSED BY EXPOSURE IN THE EVENT OF FIRE

Do not breathe combustion products. The product is combustible and, when the powder is released into the air in sufficient concentrations and in the presence of a source of ignition, it can create explosive mixtures with air. Fires may start or get worse by leakage of the solid product from the container, when it reaches high temperatures or through contact with sources of ignition.

5.3. Advice for firefighters.

GENERAL INFORMATION

Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health.

Always wear full fire prevention gear. Collect extinguishing water to prevent it from draining into the sewer system. Dispose of contaminated water used for extinction and the remains of the fire according to applicable regulations.

SPECIAL PROTECTIVE EQUIPMENT FOR FIRE-FIGHTERS

Keep the product in clearly labelled containers. Keep containers away from any incompatible materials, see section 10 for details.

The bags have to be stored in a closed, cool, and dry place. The bags have to be protected from high humidity and high temperatures above 25°C (77°F). Dusting has to be avoided, since it may create explosive mixture with air. Take precautionary measures against electrostatic charging. Keep away from open flames, heat and sparks.
